Cemented with 200 sacks "C" and 2% CaCl<sub>2</sub> (yield 1.34, weight 14.8). PD 11:15 PM 2-4-97. Bumped plug to 550 psi, OK. Cement did not circulate. WOC. Nippled up and tested to 1000# for 30 minutes. Drilled out at 11:30 AM 2-5-97. WOC 12 hours and 15 minutes. Reduced hole to 7-7/8". Resumed drilling.

TD 920'. Reached TD at 6:15 AM 2-2-97. Ran 21 joints of 11-3/4" 42# H-40 8rd ST&C (922.80') of casing set at 920'. 1-Texas Pattern notched guide shoe set at 920'. Insert float set at 872'. Cemented with 200 sacks "H", 10% A-11 and 1/4#/sack celloflake (yield 1.19, weight 15.8) and 400 sacks "C" (65-35-6) Poz, 5#/sack gilsonite, 1/4#/sack celloflake and 2% CaCl2 (yield 1.98, weight 12.4). Tailed in with 250 sacks Class C 2% CaCl2 (yield 1.32, weight 14.8). PD 12:15 PM 2-2-97. Bumped plug to 750 psi, OK. Circulated 216 sacks. WOC. Cut off and weld on flow nipple. Drilled out at 12:15 AM 2-3-97. WOC 12 hours. Reduced hole to 11". Resumed drilling.
