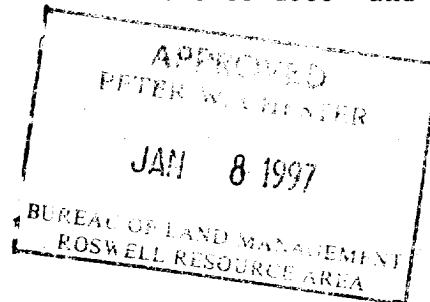

Yates Petroleum Corporation respectfully requests permission to change the casing program as follows:

- 14-3/4" hole with 11-3/4" H-40 42# casing set at 900' with 700 sacks, circulated
*11" hole with 8-5/8" 24# casing set at 1600' with 300 sacks
7-7/8" hole with 4-1/2" J-55 10.5# casing set at TD (4300') with 350 sacks

*If lost circulation is encountered, 8-5/8" intermediate casing will be set to 1600'.
If lost circulation is not encountered, will drill 11" hole to 1600' and reduce hole to 7-7/8" and drill to TD.
