Yates Petroleum Corporation wishes to amend the surface use plan to include a 3" buried X-42 steel pipeline being approximately 2000' in length all to be located on lease NM-11593. Working pressure should be approximately 500-600 PSI and will carry the gas produced by this well. This pipeline should be covered under Technical Report No. 96-SASI-085S dated June 5, 1996. The portion on northside of county road should be covered under the the clearance for Agave's two pipelines. No additional clearance should be needed. The proposed pipeline will follow the access road north to Agave Energy Company's pipelines. Then northwest about 25' off Agave's pipeline to the tie in point in the NE/SW/NE of Section 28, 6S-R25E.

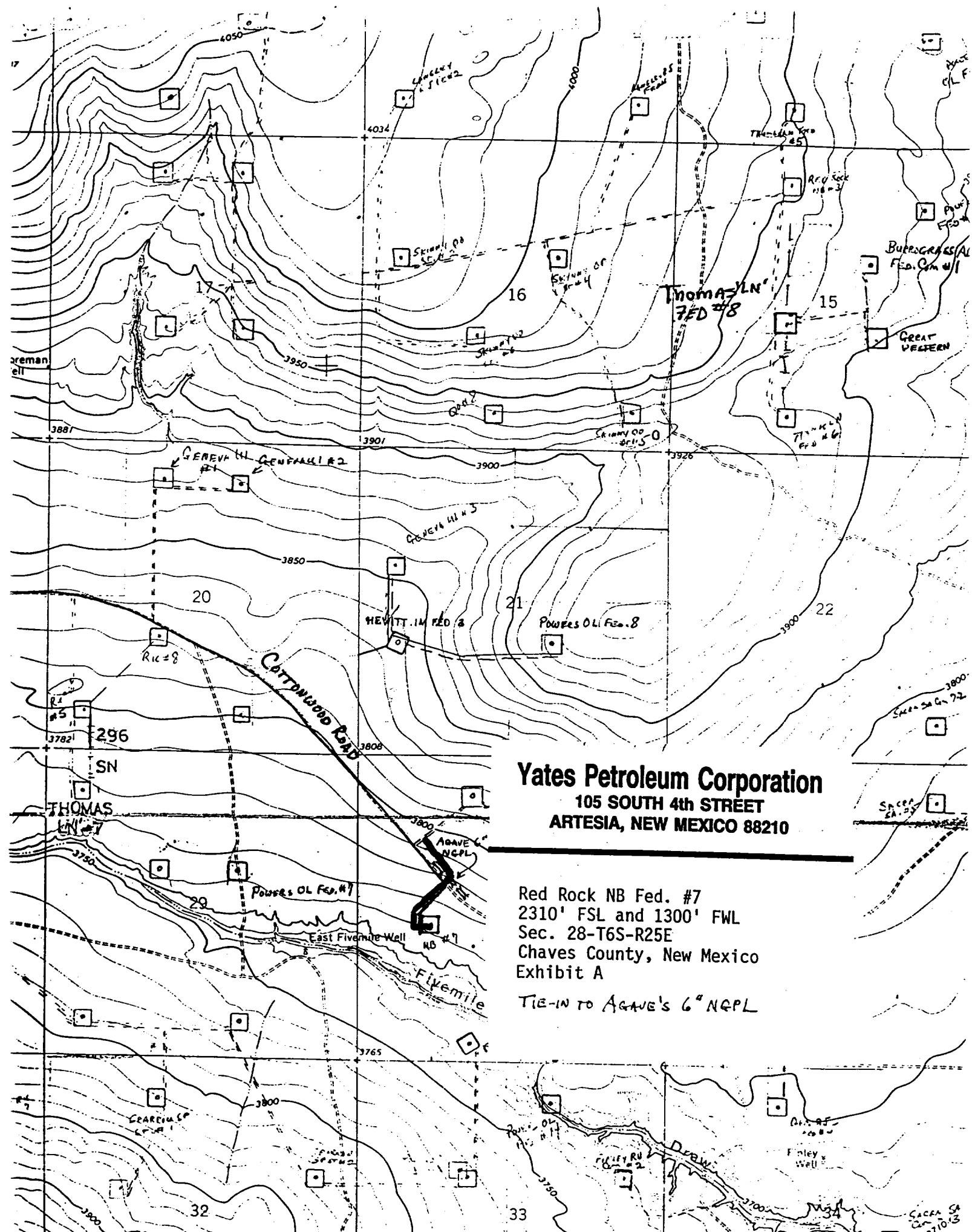
