8-5/8" hole with 7" 23# casing set at 1600' with 250 sacks of cement  
7-7/8" hole with 4-1/2" 9.5# casing set at TD (4150') with 400 sacks of cement

TO:

14-3/4" hole with 11-3/4" 42# H40 casing set at 925' with 900 sacks of cement, circulated  
\*11" hole with 8-5/8" 24# casing set at 1600' with 300 sacks of cement WOC = 10 hrs  
7-7/8" hole with 4-1/2" 10.5# J-55 casing set at TD (4150') with 400 sacks of cement WOC = 10 hrs

\*If lost circulation is encountered, 8-5/8" intermediate casing will be set to 1600'.  
If lost circulation is not encountered, will drill 11" hole to 1600' and reduce hole to 7-7/8" and drill to TD.
