Resumed drilling a 14-3/4" hole with rotary tools at 6:00 PM 7-17-97.

TD 885'. Reached TD at 2:45 AM 7-19-97. Ran 19 joints of 11-3/4" 42# H-40 (885.66') of casing set at 885'. 1-Texas Pattern notched guide shoe set at 885'. Insert float set at 841'. Cemented with 200 sacks Class H, 10% A-10-B, 10#/sack gilsonite and 1/4#/sack celloflake (yield 1.51, weight 14.6) and 400 sacks BJ Lite C, 10#/sack gilsonite, 1/4#/sack celloflake and 2% CaCl2 (yield 1.90, weight 12.66). Tailed in with 200 sacks Class C 2% CaCl2 (yield 1.34, weight 14.8). PD 10:15 AM 7-19-97. Bumped plug to 750 psi, OK. Circulated 183 sacks. WOC. Nippled up and tested to 1000# for 15 minutes, OK. Drilled out at 11:15 PM 7-19-97. WOC 13 hours. Reduced hole to 11". Resumed drilling.
