Spudded a 20" hole with rat hole machine at 2:30 PM 7-9-2000. Drilled to 40'. Set 40' of 16" conductor pipe. Cemented to surface. NOTE: Notified BLM-Roswell of operations. Resumed drilling a 12-1/4" hole with rotary tools at 11:00 pM 7-26-2000. NOTE: Notified J. R. w/BLM-Roswell of resuming operations.

TD 934'. Reached TD at 9:45 PM 7-27-2000. Ran 22 joints of 8-5/8" 24# J-55 (934.54') of casing set at 934'. 1-Texas Pattern notched guide shoe set at 934'. Insert float set at 892'. Cemented with 400 sacks Poz C (65-35), 6% D-20, 2% S-1 and 1/4#/sack D-29 (yield 1.99, weight 12.6). Tailed in with 200 sacks "C" with 2% CaCl2 (yield 1.32, weight 14.8). PD 3:45 AM 7-28-2000. Bumped plug to 1110 psi, OK. Circulated 67 sacks. WOC. Nipped up and tested to 500 psi for 15 minutes, OK. Drilled out at 9:45 PM 7-28-2000. WOC 18 hours. Reduced hole to 7-7/8". Resumed drilling. NOTE: Stan Mayo w/BLM-Roswell witnessed cementing operations.
