8-9-2000 - TIH with bit, scraper and tubing and tagged PBTD at 4133'. Circulated hole with 7% KCL water. TOOH with tubing, scraper and bit. Rigged up wireline. TIH with logging tools and ran CBL log. TOOH with logging tools. TIH with 3-3/8" casing guns and perforated 3707-3974' w/25 .42" holes as follows: 3707-3709', 13, 17, 3840-3848', 3957-3961' and 3970-3974' (1 SPF - Abo). TOOH with caisng guns and rigged down wireline. Shut well in.

8-10-2000 - TIH with tubing open ended. Nippled down BOP and nipped up wellhead. Shut well in.

8-11-14-2000 - Shut in.

8-15-2000 - Spotted 500 gallons 7-1/2% double inhibited HCL over perforations. TOOH with tubing. Shut in. Prep to frac on 8-16-2000.

8-16-2000 - Prep to frac.

8-17-2000 - Frac'd perforations 3707-3974' (Abo) (down casing) with 142700 gallons 65Q N2 foam with 35# gelled 7% KCL and 221000# 16-30 Brady sand. Spearhead 2000 gallons of 7-1/2% foam with 35# gelled 7% KCL and 221000# 16-30 Brady sand. Spearhead 2000 gallons of 7-1/2% foam with 35# gelled 7% KCL and 221000# 16-30 Brady sand.
