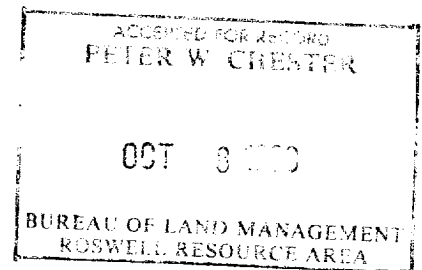

McKay Oil Corporation has plugged and abandoned this well. Well was drilled to 751'. Got stuck twice and could not retrieve drill collars. 12 1/4" bit with changeover sub, 3 8" drill collars and 16 6" drill collars were left in the hole. *Cmt. W/6 yds. Ready mix - 9/23/98*

McKay Oil will skid the rig approximately 20 feet to the south and re-drill the well. The new name assigned will be the Remmele "B" Fed. #6Y.
