Change #1

Al Springer received verbal permission from Peter Chester on 7/22/99 to cement any optional intermediate casing to a calculated tie back 200' into surface casing. The stipulated requirement of a temperature survey or bond log to determine top of cement to be dropped along with any remedial cement work as stipulated in Exhibit B Well Drilling Requirements, III Drilling Operation Requirements, B. Casing.

Change #2

Reserve pit construction (Exhibit B Well Drilling Requirements, II Well Pad Construction Requirements, 4. Reserve Pit Requirements, B.) to be changed to allow for an optional, standard pushup pit with a deep bury pit to be dug along the length of one side and adjacent to reserve pit approximately 20'-30' wide and 12'-15' deep. Reclamation of the reserve pit area would consist of allowing pit to dry and then bulldozing liner and contaminants into the bottom of pit with a least 3' of clean soil cover. The pit area to be recontoured and seeded.
