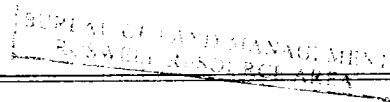

Ran 122 joints of 4-1/2" 10.5# casing as follows: 16 joints of 4-1/2" 10.5# sandblasted (686.68'); 9 joints of 4-1/2" 10.5# varnished (387.30'); 24 joints of 4-1/2" 10.5# sandblasted (1027.07') and 73 joints of 4-1/2" 10.5# varnished (3067.33') (Total 5168.38') of casing set at 5153'. Regular guide shoe set at 5153'. Float collar set at 5113'. Cemented with 600 sacks Super H, 4% Halad 344, 3% CFR3, 5#/sack gilsonite and 1#/sack salt (yield 1.69, weight 13.0). PD 2:47 PM 1-24-2000. Bumped plug to 1700 psi for 15 minutes, OK. WOC. Displaced cement with 2% KCL. Released rig at 5:00 PM 1-24-2000.
