TD 852'. Reached TD at 11:15 PM 12-22-99. Ran 19 joints of 11-3/4" 42# H-40 (854.08') of casing set at 852'. 1-Texas Pattern notched guide shoe set at 852'. Insert float set at 808'. Cemented with 265 sacks Premium Plus Halliburton Lite, 3% CaCl₂, 1/4#/sack flocele and 5#/sack gilsonite (yield 2.02, weight 12.4). Tailed in with 200 sacks Premium Plus with 2% CaCl₂ (yield 1.34, weight 14.8). PD 7:45 AM 12-23-99. Bumped plug to 600 psi, OK. Circulated 111 sacks. WOC. Cut off and welded on flow nipple. Drilled out at 11:30 AM 12-27-99. WOC 99 hours and 45 minutes. Reduced hole to 11". Resumed drilling.

NOTE: Reduced hole to 7-7/8" at 1500'.
