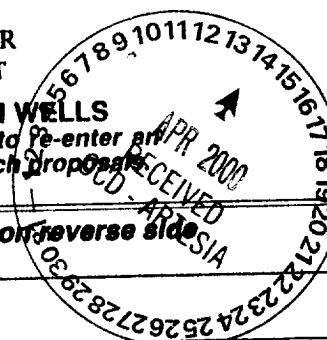

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Spudded a 26" hole with rat hole machine at 12:45 PM 1-10-2000. Drilled to 40'. Set 40' of 20" conductor pipe. Cemented to surface. Resumed drilling a 12-1/4" hole with rotary tools at 5:00 PM 1-13-2000. NOTE: Notified J. R. w/BLM-Roswell of spud and intent to run casing.

TD 930'. Reached TD at 9:30 AM 1-15-2000. Ran 22 joints of 8-5/8" 24# (916.83') of casing set at 926'. 1-Texas Pattern notched guide shoe set at 926'. Insert float set at 884'. Cemented with 250 sacks Class C, .6% D20, 2% CaCl2 and 1/4#/sack celloflake (yield 1.99, weight 12.6). Tailed in with 200 sacks Class C and 2% CaCl2 with 1/2#/sack celloflake (yield 1.32, weight 14.8). PD 1:40 PM 1-15-2000. Bumped plug to 450 psi, OK. Circulated 73 sacks. WOC. Nipped up and tested to 500 psi for 30 minutes, OK. Drilled out at 6:00 AM 1-17-2000. WOC 40 hours and 20 minutes. Reduced hole to 7-7/8". Resumed drilling.
