PD 3:00 PM 1-28-2000. Bumped plug to 1000 psi for 10 minutes, OK. WOC. Released rig at 7:00 PM 1-28-2000. NOTE: Displaced with 2% KCL.

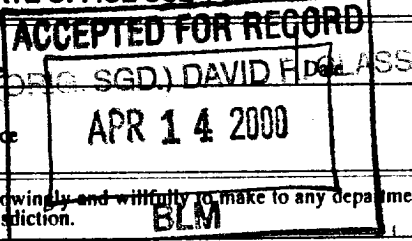
