2-15-2000 - Cleaned location, set and tested anchors. Cut off 5-1/2" casing. Moved in and rigged up pulling unit. Nippled up tubinghead. Nippled up BOP. TIH with bit, scraper and 2-3/8" tubing. Shut down for night.

2-16-2000 - Finished TIH with bit, scraper and tubing to 5165' (PBTD). POOH with tubing, scraper and bit. Rigged up wireline. TIH with logging tools and ran GR/CCL/CBL log. TOOH with logging tools. TIH with 4" casing guns and perforated 5014-5088' w/42 .49" holes as follows: 5014-5018' (10 holes); 5038-5058' (21 holes) and 5075-5088' (11 holes) (Wolfcamp). TOOH with casing guns and rigged down wireline. TIH with RBP, packer, seating nipple and 2-3/8" tubing to 5122'. Set RBP at 5122'. Set packer at 4980'. Shut well in for night.

2-17-2000 - Acidized perforations 5014-5088' (Wolfcamp) with 3400 gallons 15% iron control HCL acid and ball sealers. Swabbed. Shut well in for night.

2-18-2000 - Bled well down. Swabbed. Unset packer and RBP. Set RBP at 4980' and tested to 500#, OK. Shut well in.

2-19-2000 - Shut in.
