- 6/18/02 Re-frac Abo with 110,000 gals 55 Quality CO2 foamed 35# x-linked gelled 7% KCL water carrying 250,000# 16/30 Brady sand.
- 6/26/02 Drilled out composite plug. The Wildcat Pennsylvanian Gas and Undesignated Pecos Slope Abo are commingled.

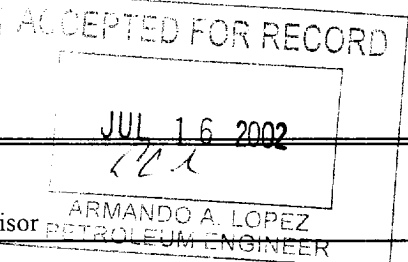
