Drilled a 12 1/4" hole to 2245'. Ran 53 joints (2247') of 24# and 32#, J-55 8 5/8" casing. Cemented with 750 sxs Innerfill C with 1/4# flocele. Tailed by 200 sxs Premium Plus with 2% CaCl. Circulated 225 sxs. Plug down at 3:00 P.M. on 12/01/99. WOC 18 hours. Tested to 1000# for 30 minutes, test okay. Resume drilling a 7 7/8" hole.
