8-5-7-2000 - Moved in and rigged up pulling unit. Cut off and welde don 5-1/2" bell nipple. Set anchors.

8-8-2000 - TIH with bit, scraper and 2-3/8" tubing. Tagged PBTD at 6450'. Circulated hole with 2% KCL water. TOOH with bit, scraper and tubing. Shut down for night.

8-9-2000 - Rigged up wireline. TIH with logging tools and ran CBL/CCL/GR log. TOOH with logging tools. TIH with TCP guns, 2-3/8" tubing joint, tubing release, vent, 1 joint of 2-3/8" tubing, packer with on/off tool, 1.81" F profile and 2-7/8" tubing. Set packer and nipped down BOP. Nipped up wellhead. Fired guns - perforated 6236-6252' w/65 .38" holes (4 SPF - Ordovician). Shut well in.

8-10-2000 - Flow tested. TOOH and laid down TCP guns. TIH with packer and set packer at 6150'. Nipped down BOP. Nipped up wellhead. Shut well in.

8-11-2000 - Bled well down. Swabbed & flow tested. Acidized perforations 6236-6252' with 750 gallons 20% iron control HCL acid. Swabbed & flow tested. Shut well in. Released well to production department.
