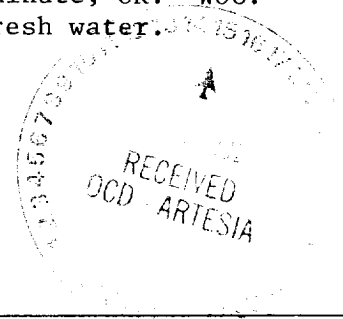

Top marker set at 3839'. Cemented with 550 sacks Pecos Valley Lite, 1#/sack D-44, 4#/sack D-42, 0.2% D-65, 0.3% D-167, 0.2% D-46 and 0.15% D-13 (yield 1.42, weight 13.0). PD 1:30 PM 8-10-2000. Bumped plug to 2200 psi for 1 minute, OK. WOC. Released rig at 7:30 PM 8-10-2000. NOTE: Displaced with 154 bbls fresh water.
