Spudded a 20" hole with rat hole machine at 11:00 AM 10-5-2000. Drilled to 40'. Set 40' of 16" conductor pipe. Cemented to surface. NOTE: Notified OCD-Artesia answering service. Resumed drilling a 12-1/4" hole with rotary tools at 9:15 PM 10-8-2000.

TD 1095'. Reached TD at 6:15 PM 10-10-2000. Ran 26 joints of 8-5/8" 24# J-55 (1095.88') of casing set at 1095'. 1-Texas Pattern notched guide shoe set at 1095'. Insert float set at 1053'. Cemented with 400 sacks Poz C (65-35), 6% D-20, 2% S-1 and 1/4#/sack D-29 (yield 1.99, weight 12.6). Tailed in with 200 sacks "C" with 2% S-1 (yield 1.32, weight 14.8). PD 3:15 AM 10-11-2000. Bumped plug to 660 psi, OK. Circulated 51 sacks. WOC. Nipped up and tested to 500 psi for 15 minutes, OK. Drilled out at 9:15 PM 10-11-2000. WOC 18 hours. Reduced hole to 7-7/8". Resumed drilling. NOTE: Notified OCD-Artesia answering service of operations.
