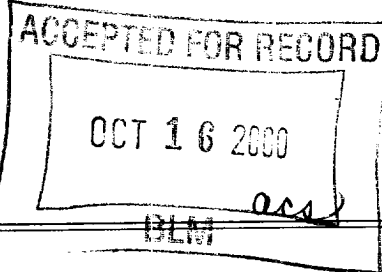

Plug down at 10:00 a.m. 10/03/00. Ran temp. survey indicated TOC at 810'. Tagged cement at 810' w/1" pipe. Brought cement to surface in 18 stages using 950 sxs premium cement. Completed 1" job at 8:08 p.m. 10/5/00.

10/6/00 -- Pressure tested BOP & 8-5/8" csg. to 1000 psi for 30 minutes. Held ok.
