Insert float set at 890.58'. Cemented with 400 sxs 35/65 Poz C + 2% CaCl₂ + .25 # Celloflake (yld 1.99, wt 12.6) Tailed in with 200 sxs C + 2% CaCl₂ (yld 1.32, wt 14.8). PD at 12:00 midnight 11/16/00. Bumped plug to 530 psi, held OK. Circ 58 sxs. WOC.

11/17/00 - Drilled out at 9:00 PM. WOC 21 hours. Reduced hole to 11" and resumed drilling.

11/18/00 - Drilled to 1523'. Displaced hole with 10# brine. No loss. Reduced hole to 7-7/8" and resumed drilling.

11/19 - 12/1/00 - Drilling.

12/2/00 - Reached TD of 5530' at 10:45 AM.

12/3/00 - RU loggers and log. Cut sidewall cores. Logger's TD 5495'.

Notified Stan Mayo of Roswell BLM of intentions to run 5-1/2" production string.

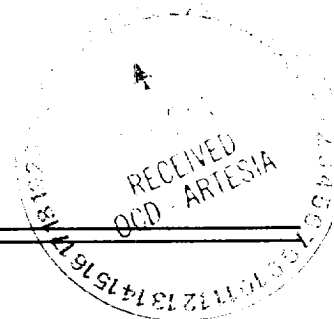
