Cemented with 500 sxs Pecos Valley Lite with 1 pps D44, 4 pps D24, .2% D65, .3% D167, .2% D46, .15% D13 (yld 1.42, wt 13). PD at 10:15 PM. Bumped plug to 1520 psi for 5 mins.

Had to wash down approximately 20', circulate for 1 hour after on bottom with casing.

Good circulation throughout job.
