Notified Phil Hawkins with OCD of spud.

6/16/01 - Resumed drilling at 12:01 AM with rotary tools,

6/17/01 - Reached TD of 14-3/4" hole at 905' at 5:00 AM.

Ran 21 joints (905.99') 11-3/4" 42# P110 casing set at 905'. Texas Pattern guide shoe set at 905'. Insert float set at 863.86'. Cemented with 400 sxs 35:65:6 C + 2% CaCl₂ + 1/8 pps polyflake (yld 1.99, wt 12.6). Tailed in with 200 sxs C + 2% CaCl₂ (yld 1.32, wt 14.8). Plug down at 1:30 PM. Bumped plug to 600#, held OK. Circ 85 sxs. WOC. Notified Phil Hawkins with OCD before starting pipe.

6/18/01 - Drilled out at 8:15 AM. WOC 18 hrs 45 mins. Reduced hole to 11" and resumed drilling.

6/19/01 - Drilled to 1528'. Displaced hole with 10# brine, no fluid loss. Reduced hole to 7-7/8" and resumed drilling.
