McKay Oil Corporation proposes to construct a natural gas flow line from the Pierce "B" Fed. #2 to connect with McKay Oil's existing gas gathering system. The flow line will be constructed of 2-3/8" line pipe and will be initially layed on the surface except where the line will cross the county road just south of the location. After testing the well and determining it is capable of production we will then bury the line. The flow line will run along the west side of the access road to the location.
