6/5/01 - Resumed drilling with rotary tool with 14-3/4" hole at 9:45 AM.

6/6/01 - TD of 14-3/4" hole at 910' at 5:30 PM. Ran 21 j's (893.09') of 11-3/4" 42# casing set at 910'. Texas Pattern guide shoe set at 910'. Insert float set at 867.01'. Cemented with 450 sxs 35:65:6 C + 2% CaCl2 + 1/8 pps polyflake (yld 1.99, wt 12.6). Tailed in with 200 sxs C + 2% CaCl2 (yld 1.32, wt 14.8).

6/7/01 - PD at 1:00 AM. Bumped plug to 880#, held OK. Circ 78 sxs. WOC.

Drilled out at 8:15 PM. WOC 19 hrs 15 mins. Reduced hole to 11" and resumed drilling.

6/8/01 - Drilled to 1500'. Displaced hole with 10# brine, no loss. Reduced hole to 7-7/8" and resumed drilling.

6/13/01 - Reached TD of 4114' at 5:00 AM. Run open hole logs. Logger's TD 4109'.
