8/2/01 - Reached TD of 12-1/4" surface hole at 1118' at 1:30 PM. Ran 27 joints (1120.27') 8-5/8" 24# casing set at 1118'. Texas Pattern guide shoe set at 1118'. Insert float set at 1078'. Cemented with 400 sxs 35:65 Poz with 6% D20 + 2% S1 + .125 pps D130 (yld 1.99, wt 12.6). Tailed in with 200 sxs C + 2% S1 (yld 1.32, wt 14.8). PD at 7:30 PM. Bumped plug to 627#, held OK. Circ 42 sxs. WOC. Notified Van Barton with OCD of operations.

8/3/01 - Drilled out at 1:30 PM. WOC 18 hours. Reduced hole to 7-7/8" and resumed drilling.
