Yates Petroleum Corporation proposes to release packer at 5546' and set a 5-1/2" composite plug at 5700' to isolate the Strawn perms. Perforate Wolfcamp 5376'-5384' (32 holes). Stimulate as needed. If the Wolfcamp zone is not productive, set a 5-1/2" cement retainer at 5360' and squeeze Wolfcamp perms 5376'-5384' w/100 +/- sx Class "H" cement with additives. Perforate Abo 4470'-4488' (19 holes), 4494'-4502' (9 holes), 4518'-4526' (9 holes), 4613'-4621' (9 holes), 4682'-4700' (19 holes), 4720'-4724' (5 holes), 4746'-4750' (5 holes) for a total of 75 holes. Stimulate as needed.
