11/30/01 - Resumed drilling with rotary tools at 6:45 PM.

12/02/01 - Reached TD of 14-3/4" hole at 941' at 8:45 AM.

Ran 22 joints (943.46') 11-3/4" 42# casing set at 941'. Texas Pattern guide shoe set at 941'. Insert float set at 896.48'. Cemented with 500 sxs 35:65:6 C + 6% D20 + 5 pps D24 + 2% S1 + .125% D30 (yld 1.99, wt 12.6). Tailed in with 200 sxs C + 2% S1 (yld 1.32, wt 14.8). Plug down at 6:15 PM. Bumped plug to 750#, held OK. Circ 83 sxs. WOC. Notified Van Barton with OCD before starting pipe.

12/03/01 - Drilled out at 4:45 PM. WOC 19 hrs 30 mins. Reduced hole to 11" and resumed drilling.

12/04/01 - Drilled to 1529'. Displace hole with 10# brine. No fluid loss. Reduced hole to 7-7/8" and resumed drilling.
