Ran 22 joints (935.89') 11-3/4" 42# H40 casing set at 936'. Texas pattern guide shoe set at 936'. Insert float set at 893.05'. Cemented with 500 sxs 35:65 Poz C with D20 + 2% S1 + 5 pps D24 + 1/8 pps D130 (yld 1.99, wt 12.6). Tailed in with 200 sxs C with 2% S1 (yld 1.32, wt 14.8). PD at 12:15 PM. Bumped plug to 900 psi, held OK. Circ 88 sxs. WOC.

10/5/01 - Drilled out at 7:45 AM. WOC 19 hours 30 minutes. Reduced hole to 11" and resumed drilling.
