4/18/02 - Reached TD of 12-1/4" hole at 932' at 8:30 AM.

Ran 21 joints (872.72') 8-5/8" 24# casing set at 872'. (Note: Casing stuck 50' off bottom. Received verbal permission from Bryan Arrant to cement casing there.) Texas Pattern guide shoe set at 872'. Insert float set at 829.24'. Cemented with 100 sxs A + RFC (yld 1.62, wt 14.2) and 400 sxs 35/65 Poz C + 6% D20 + 5 pps D24 + 2% S1 + .125 pps D130 (yld 1.99, wt 12.6). Tailed in with 200 sxs C + 2% S1 (yld 1.32, wt 14.8). PD at 12:45 PM. Bumped plug to 768#, held OK. Did not circulate. WOC.

Ran temperature survey, TOC 90'. Received verbal permission from Van Barton with OCD to redimix to surface. Redimix with 4 yards.

4/19/02 - Drilled out at 10:15 AM. WOC 21-1/2 hours. Reduced hole to 7-7/8" and resumed drilling.
