If the Cisco zones are not productive, set a 5-1/2" CIBP at 5660' and cap the plug w/35' of cement. Perforate Abo 4452'-4458' (7 holes), 4464'-4466' (3 holes), 4474'-4477' (4 holes), 4482'-4485' (4 holes), 4526'-4532' (7 holes), 4542'-4546' (5 holes), 4568'-4572' (5 holes), 4584'-4588' (5 holes), 4610'-4620' (11 holes), 4713'-4720' (8 holes), 4808'-4818' (11 holes), 4822'-4825' (4 holes) for a total of 74 holes. Stimulate as needed.
