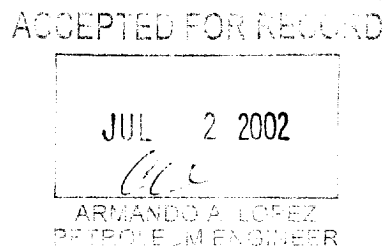

Cemented with 3 sx Frac Gel + 100 sx RFC A 10:2 + 10#/sx Gilsonite + 500 sx 35:65:6 "C" + 5#/sx Gilsonite + 2% CaCl2 + 1/4#/sx polyflake. Tailed in with 200 sx "C" + 2% CaCl2. PD at 9:15 AM 6-10-02. Circulated 87 sx. WOC 18 hours and 30 minutes. Reduced hole to 7-7/8" and resumed drilling.
