It will be staked from the northeast corner of the well loc extending east around the well pad, then turning south for approximately 0.9 of a mile to the proposed Pay "Ayy" Federal Com. #2 location, then turn east for approx. 10,718 to the point of origin as filed under road right-of-way application submitted April 17, 2002. In the event the road right-of-way application is approved for the alternate rou the access road will begin at the southwest corner of the location.
