2. That TED F. JOHNSON, JR. ET. AL. is the operator of a well drilled on land be-

longing to N. E. MYRICK, whose address is ROUTE NO. 1, FORT SUMNER,

NEW MEXICO, said well being drilled to test for hydrocarbons and/or carbon dioxide gas and described as the MYRICK No. 1, being located 2310 feet from the NORTH line and 1660 feet from the EAST line of Section 18, Town-ship 2 NORTH, Range 25 EAST, NMPM, DE BACA County, New Mexico.

3. That said well was drilled to a total depth of 1539 feet, and that casing has been set and cemented as follows:

8 5/8" set at 274 feet. Cemented with 200 sacks.

5 1/2" set at 1515 feet. Cemented with 250 sacks.

4. That operator and landowner have made an agreement whereby operator (~~operator~~) HAS ~~back~~ ^{FILLED} pits, ~~layer~~ ^{COVERED} location, and ~~clear~~ ^{CLEARED} it of all junk. The agreement further provides that operator ~~is to plug~~ ^{has plugged} said well back to a plugged-back total depth of 1325 feet and transfer well to landowner for his use as a water-well. Operator will leave casing in the well as follows:

274 feet of 8 5/8" Surface casing

1515 feet of 5 1/2" Casing, Grade J-55, Wt. 15.5 lbs.

5. That when operator has complied with the provisions of Paragraph 4 above it will so notify the Oil Conservation Commission of the State of New Mexico on Commission Form C-103, together with a signed statement from the landowner that the provisions of Paragraph 4 above have been complied with to his satisfaction.
