On April 3, 1979, Panhandle Pluggers, Inc. Box 742 Pampa, Texas, 79065 moved equipment to the Charles M. Goad State well # 1, in DeBaca County. Cut out top plug and ran tubing to 120 ft. and pumped 35 sacks of cement and hole was taking fluid. on the 4-4-79, we tagged the 35 sack plug @ 22'. Mixed and pumped 20 sacks and filled 8 5/8 casing and 16" casing to surface and replaced marker. Completed on 4-4-79.
