12-23-87 MIRU Permian Basin Casing Pullers. Pumped 50 bbls 10# brine down tubing to load and kill well. TOH with 807'-25 jts 2 3/8" tubing. Ran 8 5/8" EZ drill cast iron bridge plug and set at 800'. TOH with setting tool. TIH with SN open ended and circulated with 50 Bbls mud. Pumped 35 sx class "C" cement from 800 to 671'. TOH to 440'. Pumped 35 sx class "C" from 440 to 311'. TOH to 30'. Pumped 10 sx class "C" cement from 30' to surface. Cut off casing. Installed 4' dry hole marker in accordance with NMOCC regulations. Released rig. Cut off anchors, covered pit and cleaned location.
