MIRU pulling unit & ran CBL - GR - CCL from PBD 2800' to top of cement @ 2380'. Perf Glorrietta from 2737-51' w/ 15 holes ISPT. Swabbed 120 bbls of saltwater. Set CIBP @ 2730' & dumped 14' of cement on top. Perforated lower San Andres 2679-81' & 2695-2701' w/ ISPT 10 holes. Acidize w/ 2500 gal. of 15% NeFe acid. Swab back w/ no show of oil or gas. Temp abandoned for further evaluation. Shut in well.
