Spudded well on June 12, 1964 Drilled 12 1/4 inch hole to 250 feet at which depth 1 3/4 inch surface casing was set, and cemented with 175 sacks of Cement.

Drilled 8 3/4 inch hole from 250 feet to 1861 feet and 7 7/8 inch hole from 1861 to the total depth of 7,068 feet. Total depth was reached on September 9, 1964, without encountering any commercial shows of oil or gas.

Run Gamma Ray Sonic and Petrolog logs.

Instructions
