FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

In compliance with the rules and regulations covering permanent abandonment of a well we propose:

1. Pull 7 inch cave string.
2. Leave original 8 inch casing in hole at 826 feet.
3. Set 25 feet of cement on bridge to plug hole from 850 to 875 feet.
4. Set 15 feet of cement at surface in 8 inch casing and 4 feet by 4 inch steel pipe marker.

Provided, however, that if before completion of this work written request is received from land owner for use as water well and approval is forth coming from the Commission the well will be capped rather than surface plugged with cement. Note: see letter of transmittal.
