DETAILED ACCOUNT OF WORK DONE, NATURE AND QUANTITY OF MATERIALS USED AND RESULTS OBTAINED.
Placed 140' cement plug from 14,585 to 14,445' using 40 sacks Trinity Inferno Slag-net cement.
Plug in place 9:45 AM 12-22-58. Placed 200' cement plug from 5,443 to 5243' using 36 sacks regular neat cement. Plug in place at 5:00 PM 12-22-58. Placed 30' cement plug from 30' to surface using 9 sacks regular cement. Plug in place 4:00 PM 12-23-58. Welded 10-3/4" x 1" swage w/ valve into top of 10-3/4" casing. Spotted 18 sacks cement around 10-3/4" casing.
Mud laden fluid of approximately 9% weight per gallon was placed between all cement plugs.
The following casing was left in well. 410' of 13-3/8" casing set at 431'; 1172' of 10-3/4" casing set at 1490'; 533' of 8-5/8" casing set at 5346'. A 4"line pipe marker was placed in accordance with New Mexico Oil Conservation Commission regulations. Pits and location have not been cleared at present since it will be necessary to allow pits to dry before they can be filled, and the work completed.
