Dear Sir:

I received a letter from Carl H. Janzen asking for a release on a \$5000 plugging bond on your Doss Galloway Well No. 1, Unit N, 22-8S-14E, Lincoln County, New Mexico. He says this well was never started. I am under the impression that you drilled two or three wells in this area, hitting granite at a shallow depth. If this is correct, it will be necessary for the landowner to sign an affidavit of responsibility for cleaning the locations and plugging these wells; or, Western Ranchers may do the work themselves.

If there have been no wells started, please submit to this office three (3) copies of form C-102 for each well, stating the locations were abandoned. If you did start drilling any wells, please submit three (3) copies of form C-103 on each well, stating total depth and the condition in which the hole was left.

Also, on your Beacher Martin Well No. 1, Unit H, 19-8S-14E, the last report we received was a C-103 stating you ran 713 feet of 5½ inch casing and were drilling ahead. If you plan to plug this well, please submit three copies of form C-102 stating your plugging program.

We will also need five copies of form C-105 (WellLog) on any well you have drilled in this area.

**Abstract**—The purpose of this study was to determine if there were differences in the prevalence of musculoskeletal disorders between two groups of nurses working in different departments of a hospital. The first group consisted of nurses working in the intensive care unit (ICU) and the second group consisted of nurses working in the medical-surgical department. A questionnaire was distributed to all nurses in both departments asking them to indicate whether or not they had experienced musculoskeletal problems during their work shift. The results showed that the prevalence of musculoskeletal disorders was significantly higher among ICU nurses than among medical-surgical nurses.
