Gentlemen:

The records which we have on file concerning the subject well do not reflect that any Affidavit of Responsibility for conversion to water well has ever been executed by the land owner, Mr. Ralph O. Pearson.

Since the subject well has been inactive for a considerable period of time, it must now be permanently and properly plugged in accordance with Commission rules and regulations. Please consult Mr. M. L. Armstrong, District Supervisor of the Oil Conservation Commission in Artesia, New Mexico regarding a proper plugging program. We must demand that you have this well plugged and the plugging approved no later than 90 days from this date.

Should the land owner desire to keep this well as a water well, it will be necessary not only that he execute an Affidavit of Responsibility for conversion to a water well but also that a substantial plug be set at the base of the water. Mr. Armstrong can advise you more fully in regard to this matter.
