3. That said well was drilled to a total depth of 444 feet, and that cas-
ing has been set and cemented as follows: Ran 68.5 ft. of 8 5/8" 24# casing and left
64.5 ft. hanging in well.
4. That operator and landowner have made an agreement whereby operator
