We desire to extend the depth of this test from the original proposal of 2,200' to the basement expected between 3,500' and 3,700'. We will change out the cable tool rig for a small rotary and will drill a 7 7/8" hole from the base of the cable tool hole to total depth. If production is indicated we will run 4 1/2" 9/.5# casing and cement for a production evaluation.

We plan to use W E K Rig 3 (Continental Emsco S- 45) for the deeping

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

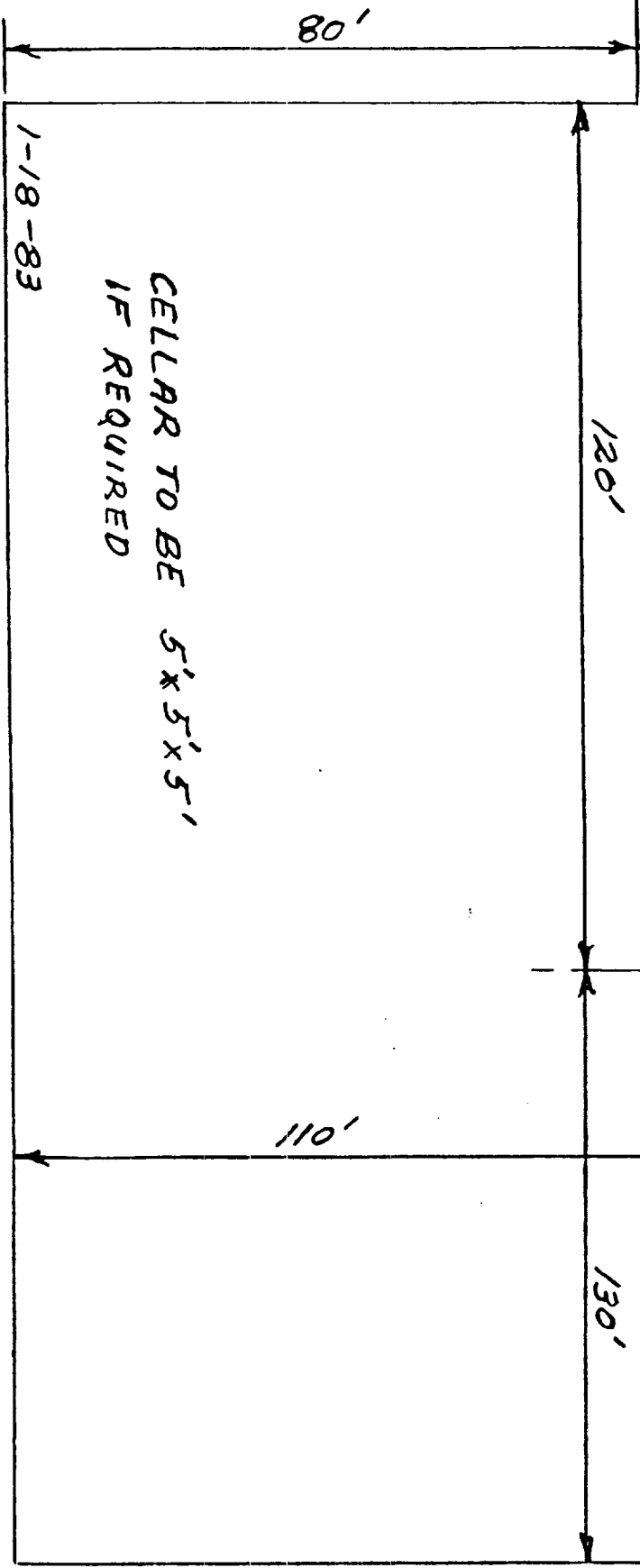
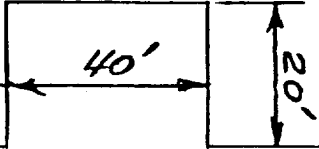
BURN PIT

STINGER

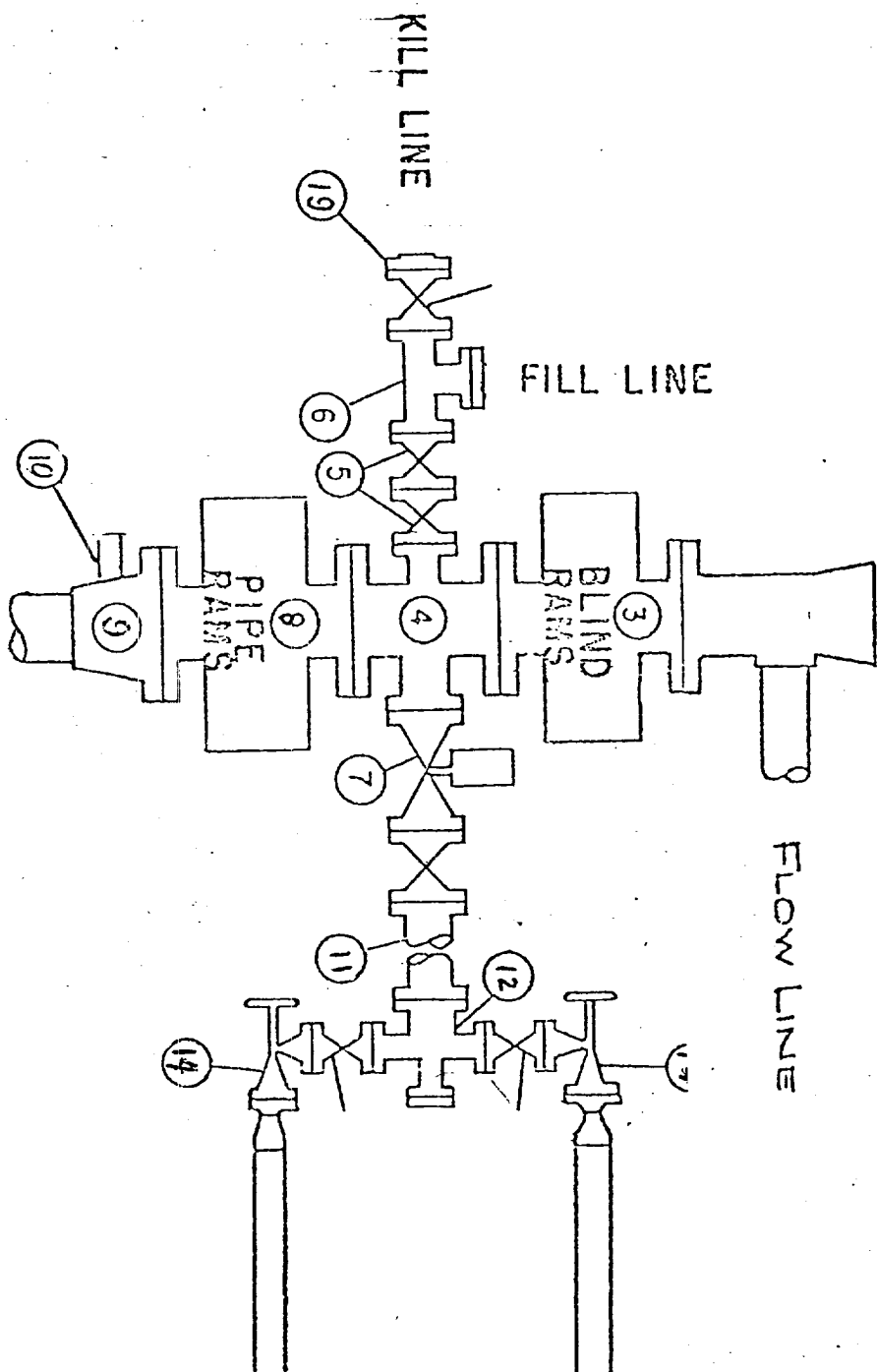

This Sundry Notice is approved subject to the following stipulations, as requested by the Forest Service.

1. Drill pad area shall be kept to a minimum so as to prevent unnecessary scalping and reclamation.
2. All refuse shall be hauled off site and disposed of in an approved sanitary landfill. A burn pit will not be allowed.
3. Access shall be restricted to the existing "two tract road". Travel on wet or muddy soils will not be allowed.
4. Mr. Kincheloe is to contact the adjacent residents and notify them of his need to drill 24 hours-per day.
