Bottom Liner - 4021', Top Liner - 3099.77', Hung in 7 5/8" set @ 3464'. Did Not Cement 5 1/2" Liner. Run Liner to Shut off water; shut off partially successful. Unable to cement due to reduced hole size, will pull & run additional 5 1/2" if more water encountered as drilling progresses.
