*Run 8-5/8" and 5-1/2" Casing to be run and cemented at depths which will be determined by the conditions encountered during drilling operations.

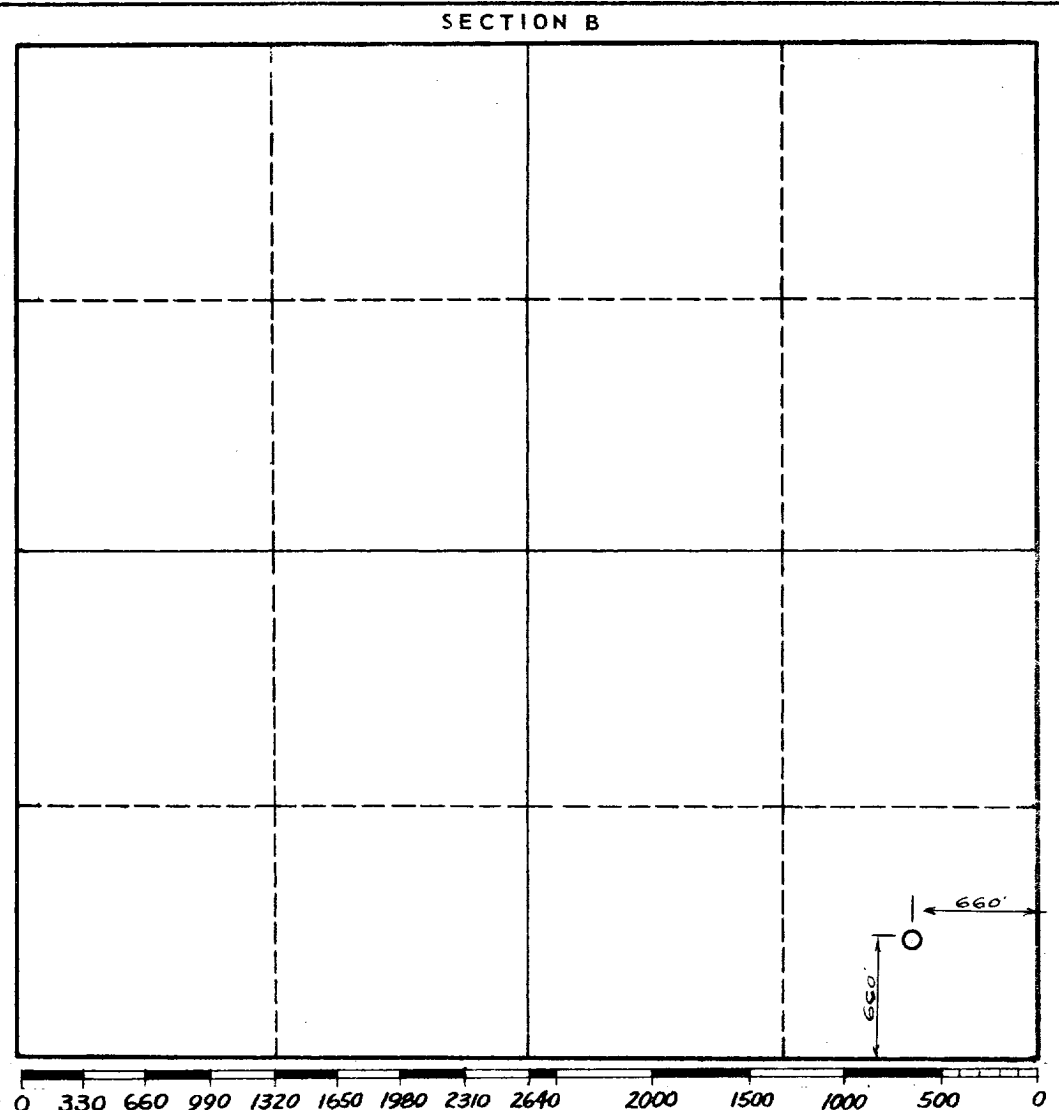
