1. Pulled 8-5/8" casing set at 1400'.
2. Filled hole with heavy mud from 1400 to 2353 TD.
3. Set 5 sack plug at 1400'.
4. Filled hole with heavy mud and set 25 sack plug at 630-680'.
5. Pulled 10-3/4" casing at 424'.
6. Filled hole with heavy mud and set 10 sack cement plug at 380'.
7. Filled hole with heavy mud and set 10 sack cement plug at 260'.
8. Filled hole with heavy mud and set 5 sack cement plug in top and bottom of 13-3/8" surface casing at 72'.
9. Levelled location and set required marker.
10. Location ready for inspection.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
