It was hoped that the well would be drilled deeper at a later date. ~~The well~~ Arrangements were made in April, 1974 to allow the Hughes Brothers (ranchers in the area) to utilize the well as a fresh water supply well for their ranch until such time that we should desire to reenter the well. Ownership of the Casing and hole is retained by W. W. West, with the Hughes Brothers having the right to place their own equipment on the well for purposes of producing fresh water. After receiving this form, I wrote Marion Hughes concerning the status of the well. Marion replied that they have placed their equipment on the well and are presently producing it as a fresh water supply well.
