Drilled to 186 feet. At this point we struck hard sandstone resulting in 21' of bad hole. Total depth 207 feet. We wish to plug and abandon, by filling hole with sand and mud to surface, as no water or oil appeared. We do not think it is necessary to erect the regulation marker, as there is no danger of any caves.
