1. Set G.I. Bridge Plug at 6140' and perforated 5-1/2" casing 6065'-62' w/2SPT and cemented with 200 sz. cement.
2. Perforated 5907-5865; 5830-5820; 5805-5745.
3. Stimulated 5907-5865 w/5000 gal. 16%, 5907-5820 w/15,000 gal. LSTNE; 5805-5745 w/10,000 gal. LSTNE and 60,000 gal water frac w/1/2# and/gal.

On test 2-1-61, well pumped 11 BO, 16 BW in 24 hrs. GOR 1612, GCR 44%.
